Meeting Called to Order approx: 9:31 AM with the Pledge of Allegiance led by D. Smith Jr.

OPENING REMARKS / OFFICER REPORTS:

Director: R. Breuninger opened the meeting with stating "lets get this shit show going" – LOL.

R. Breuninger announced that \$2,700 was raised from the May 4th charity ride for Celebrate the Children. He expressed his "Gratitude and Thanks" to all chapter members for the help and

support that was given that day. R. Breuninger stated that the chapter had a "hell of a turnout" – about 25% of participants who attended the ride were Garden State Chapter Members. - R. Breuninger announced that he has scheduled a "Ride Like A Pro" class for 6/22/2024. He announced that right now there are 4 to 5 members signed up. He needs an additional 4 to 5 members to sign up in order to keep the price down (\$175.00). If attendance turns out to be low the price will increase to \$200.00. He explained to members that this particular course is a "basic" course. It's the first step in becoming a showoff like himself LOL. He concluded by saying, "these are perishable skills that need fine turning yearly".

Assistant Director: R. Seitz opened with presenting Webmaster, M. Durenberger with a National HOG plaque. M. Durenberger was absent for the March chapter meeting when plaques were presented to chapter officers. Again, this is National HOG's way of recognizing/rewarding the people who are in officer roles and the work that each officer contributes to the chapter. "Thank You... M. Durenberger"

- R. Seitz then shared with members that "today" was our illustrious leader's (R. Breuninger), birthday. R. Seitz presented R. Breuninger with a "Burger King" crown and the chapter then broke out in song... singing Happy Birthday to R. Breuninger. Wishing R. Breuninger many many more!!!!
- R. Setiz then asked that chapter members attending the Nashville Trip to please stay after the conclusion of the chapter meeting. for a brief meeting concerning Nashville Trip.

Treasurer: B. Papetti was absent. DJ Lannign provided the current balance in the chapter's bank account. Account is in good standing.

Secretary: DJ Lannigan shared that for any member who's National HOG membership has expired... she will be sending out a friendly email reminder to members to please renew their membership with National HOG. She explained that memberships with National HOG need to be in good standing in order to remain a local chapter member. Also members who do not renew their National HOG membership will need to sign a waiver in order to go on chapter rides.

COMMITTEE REPORTS:

Head Road Captain: B. Gould spoke about the "new" rider sign-in sheet pointing out that anyone on the sheet that was a "red" issue box coming up next to their name will need to sign a "waiver" when attending a chapter ride. For any rider in this situation, who does not understand what the issue may be, they should speak with an officer.

Membership Officer: D. Borowsky shared as of present the chapter has 120 paid/active members recorded.

 D. Borowsky introduced new member: M. Schattner; favorite color is blue; rides an Indian; new member – C. Carreira; favorite color orange; rides a Lowrider. **Safety Officer:** H. Olbrich was absent. However, R. Breuninger spoke about 2 safety topics he: Shared with members:

- One being that all "helmets" have an expiration date. Encouraged members to check their helmet expiration dates. He stated that helmets usually have a 3-to-5-year life span.
- Second topic R. Breuninger canvassed the group inquiring as to "who in the room has experience in pulling a trailer, and who does not". He then shared a video of a person who does not have experience in pulling a trailer where there was a motorcycle and cones that had been loaded on a trailer, and how the motorcycle was moving/shifting as the trailer was in tow. He explained this was happening because the trailer was not loaded correctly... the weight on the trailer was not distributed forward enough, or evenly. There was further discussion amongst group members that a trailer also needs to be level and to make sure when towing you have the proper materials to tie-down correctly.

Historian: J. Gennarelli shared that the PowerPoint presentation being shown was of the June 2023 chapter ride to the Irish Cottage. He then talked about a project he has been involved with in regard to putting together a book entitled "A Day in A Life in NJ". He shared that a picture from the June 2023 ride, which is a group photo, that was taken in front of the Irish Cottoage, has been published in this book – which he showed to everyone. Garden Sate HOG Chapter made the book. Thank you, J. Gennarelli.
